

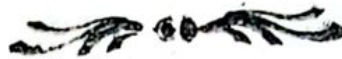

Note:- 1. Mark in the subject in which the candidate has failed are close in a circle.

2. The minimum pass marks in Arithmetic and Nepali Srestha or Domestic Arithmetic including household Account are 30 marks in total provided a candidate gets not less than 10 marks in either group.

3. The total number of marks in the nine subjects shall be 900 in the aggregate and the minimum pass marks shall be 288

4. In case of the candidate taking one more extra optional subject, credit shall be given for same in divisions as here under. If a candidate has passed in the compulsory subjects and also in the aggregate, the marks in excess of 25 obtained by him in his Extra optional subjects shall be added to his aggregate and the aggregate so obtained shall determine his division and place list.
